**MINUTES ON SENTENCING  
Day Four**

**6:11-cr-277-Orl-31GJK**

Court adjudicates Defendant Guilty as to Count One of the Indictment.

**SENTENCE IMPOSED as to Count One of the Indictment.**

**INCARCERATION:** 12 months plus one day.

**SUPERVISED RELEASE:** 3 years. *Special conditions of supervised release:* Mandatory drug testing requirements are waived. Defendant shall cooperate in the collection of DNA.

**FINE** and cost of imprisonment are waived.

**SPECIAL ASSESSMENT** of \$100.00 is due immediately.

The defendant is **remanded** to the custody of the United States Marshal for processing and release.

Defendant advised of right to appeal.

Acknowledgment of Right to Appeal filed in open court.

**6:12-cr-63-Orl-31GJK**

Court adjudicates Defendant Guilty as to Count One of the Indictment.

**SENTENCE IMPOSED as to Count One of the Indictment.**

**INCARCERATION:** 8 months. This term shall run consecutive to the term of imprisonment imposed in 6:11-cr-277.

**SUPERVISED RELEASE:** 3 years. This term shall run concurrently with the term of supervision imposed in 6:11-cr-277. *Special conditions of supervised release:* Mandatory drug testing requirements are waived. Credit conditions imposed. IRS conditions imposed. Defendant shall cooperate in the collection of DNA.

**FINE** and cost of imprisonment are waived.

**SPECIAL ASSESSMENT** of \$100.00 is due immediately.

**RESTITUTION** ordered in the amount of \$5,587.00, payable to the Internal Revenue Service. Restitution shall be paid jointly and severally with Jonathan Paul Jimenez, a co-Defendant in this case.

The Court waives the payment of interest on restitution.

Defendant shall begin making monthly payments toward his financial obligations in the amount of \$200.00

The defendant is **remanded** to the custody of the United States Marshal for processing and release.

Defendant advised of right to appeal.

Acknowledgment of Right to Appeal filed in open court.
