10 MN: *Hello?*

11 SA: Peace be upon you.

12 MN: And upon you with God's mercy.

13 SA: How are you?

14 MN: Welcome.

15 SA: Is Ramadan at your place?

16 MN: No, he is not here. I think he took his car to Yussri's.

17 SA: *I see, I see*, fine. Good, God willing. Brother, these people are about to drive me crazy.

18 MN: Who are these people?

19 SA: All of them, all of them together, those from Damascus, I mean.

20 MN: Let them get lost.

21 SA: My brother, let them get lost, but in the end, I want the way that they get lost to be a
22 respectable way. *[Sighing]* I am trying to prepare a *proposal* now. I want to finish with
23 this thing. That one, that's it, I mean *almost*, I mean, Bashir . . . *Got out*, I mean.

24 MN: No!

25 SA: *Yeah. Almost there*, I mean, that's it, I mean. Soon, he will curse me, so I told him to
26 consider it over. I didn't pressure him or anything, pressure him, pressure him in what? I

1 told him that we will make a *proposal* now stating that these people now, those two don't
2 want to meet, neither Abu Hassan nor Fadl.

3 MN: Yes.

4 SA: And therefore I am not going to waste my time and get into all these *problems* because
5 there is no quorum and everything turns out to be . . . they want to obstruct the matter, of
6 course, I mean. You see? *And they are cooking something, whatever it is, I don't care,*
7 you know. I honestly wanted to suggest, that all the people outside withdraw, and I will
8 contact the 25 or 26, those who are involved ... And give them the *list of six* to choose
9 three.

10 MN: Um.

11 SA: But this brother objected. He told me: "No, this will not work, this is not legal and I don't
12 know what." I told him: "Okay, give me another *proposal*."

13 MN: Give me a law.

14 SA: What?

15 MN: Tell him: "Give me any law."

16 SA: Yeah, give another *proposal*, I mean, I told him in the end: "*Who cares* how people
17 are?" He's got nothing.

18 MN: Is that all?

19 SA: What?

20 MN: Is that all? I mean, is that all the issue?

21 SA: No, that's not all of it or part of it. The question in the end, I told him: "You, honestly, I
22 mean, are disgusting me, and I, honestly, *I am not going to spend one more minute*". . . *In*
23 *this,*" I mean, *in this shit*, honestly.
