Dear Attorney General Holder:

We are writing to request that you host a meeting with leaders of the American Muslim community to discuss the decline in relations between the American Muslim community and the Department of Justice as well as ways to repair it.

It has been brought to our attention that some American Muslim groups are deeply concerned over a series of Department of Justice tactics they view as questionable and coercive.

Their concerns include:

- A recent report from The Los Angeles Times asserting that the FBI employed a convicted forger to infiltrate California mosques¹. Interestingly, leadership of that community reported the infiltrator to law enforcement as a potential terrorist.
- A bulletin circulated by the regional homeland security data and analysis North Texas
 Fusion System that identified as "imperative" the need for law enforcement officers to
 report on constitutionally protected activities undertaken by American Muslims to engage
 their elected representatives.
- Reports from Somali Muslims in Minnesota and elsewhere expressing concern about FBI religious profiling procedures².
- Evidence that the FBI or other government entities are working or contracting with foreign governments to interrogate U.S. citizens who are Muslim³.
