SECOND: The name of the corporation is

Masjid Jamaat al-Muslimeen, Inc.

THIRD: Purpose:

The purpose of this corporation is to oversee the religious direction of the educational component of the Islamic membership and all resources received. The religious services are conducted daily.

FOURTH: Election of Trustees:

A. Time and manner for the election of new Trustees:

Trustees are elected from amongst the membership. A trustee serves 2 years and elections are held in February in odd years. Trustees are nominated by the existing board.

B. Qualifications of those able to be elected as a Trustee:

A trustee must be a minimum of 18 years old and have at least one year of active membership in the Masjid Jamaat al-Muslimeen community.

C. Qualifications of those able to vote for Trustees:

Members who have at least one year of active membership and are at least 18 years old are eligible to vote for Trustees.
