THE SKAGIT COUNTY PROSECUTING ATTORNEY states:

That in Skagit County, Washington, ARCAN CETIN, did commit the crimes of:

Count I

Murder in the First Degree – Premeditated Murder – RCW 9A.32.030(1)(a) – Class A Felony

On or about September 23, 2016, in the County of Skagit, State of Washington, the above-named Defendant, with a premeditated intent to cause the death of another person, to-wit: S.L., caused the death of said person; contrary to Revised Code of Washington 9A.32.030(1)(a).

Adult Penalty: (Maximum Penalty - Life imprisonment and/or a \$50,000 fine pursuant to RCW 9A.32.030(2) and RCW 9A.20.021(1)(a), plus restitution and assessments.)

(Minimum Penalty - Pursuant to RCW 9.94A.540(1)(a), this crime is punishable by no less than twenty (20) years mandatory total confinement imprisonment without availability of furlough, work release, earned release time, or other leave of absence from confinement during such minimum twenty (20) year term except for emergency medical treatment or an extraordinary medical placement under RCW 9.94A.728(4).)

(If the defendant has previously been convicted on two separate occasions of a "most serious offense" as defined by RCW 9.94A.030(32), in this state, in federal court, or elsewhere, the mandatory penalty for this offense is life imprisonment without the possibility of parole pursuant to 9.94A.030(32)(a) and 9.94A.120(4) or 9.94A.570.)

Count II

Murder in the First Degree – Premeditated Murder – RCW 9A.32.030(1)(a) – Class A Felony

On or about September 23, 2016, in the County of Skagit, State of Washington, the above-named Defendant, with a premeditated intent to cause the death of another person, to-wit: W.C.E., caused the death of said person; contrary to Revised Code of Washington 9A.32.030(1)(a).

Adult Penalty: (Maximum Penalty - Life imprisonment and/or a \$50,000 fine pursuant to RCW 9A.32.030(2) and RCW 9A.20.021(1)(a), plus restitution and assessments.)

(Minimum Penalty - Pursuant to RCW 9.94A.540(1)(a), this crime is punishable by no less than twenty (20) years mandatory total confinement imprisonment without availability of furlough, work release, earned release time, or other leave of absence from confinement during such minimum twenty (20) year term except for emergency medical treatment or an extraordinary medical placement under RCW 9.94A.728(4).)

Count III

Murder in the First Degree – Premeditated Murder – RCW 9A.32.030(1)(a) – Class A Felony

On or about September 23, 2016, in the County of Skagit, State of Washington, the above-named Defendant, with a premeditated intent to cause the death of another person, to-wit: S.K.M., caused the death of said person; contrary to Revised Code of Washington 9A.32.030(1)(a).

Adult Penalty: (Maximum Penalty - Life imprisonment and/or a \$50,000 fine pursuant to RCW 9A.32.030(2) and RCW 9A.20.021(1)(a), plus restitution and assessments.)

(Minimum Penalty - Pursuant to RCW 9.94A.540(1)(a), this crime is punishable by no less than twenty (20) years mandatory total confinement imprisonment without availability of furlough, work release, earned release time, or other leave of absence from confinement during such minimum twenty (20) year term except for emergency medical treatment or an extraordinary medical placement under RCW 9.94A.728(4).)

Count IV

Murder in the First Degree – Premeditated Murder – RCW 9A.32.030(1)(a) – Class A Felony

On or about September 23, 2016, in the County of Skagit, State of Washington, the above-named Defendant, with a premeditated intent to cause the death of another person, to-wit: B.D., caused the death of said person; contrary to Revised Code of Washington 9A.32.030(1)(a).

Adult Penalty: (Maximum Penalty - Life imprisonment and/or a \$50,000 fine pursuant to RCW 9A.32.030(2) and RCW 9A.20.021(1)(a), plus restitution and assessments.)

(Minimum Penalty - Pursuant to RCW 9.94A.540(1)(a), this crime is punishable by no less than twenty (20) years mandatory total confinement imprisonment without availability of furlough, work release, earned release time, or other leave of absence from confinement during such minimum twenty (20) year term except for emergency medical treatment or an extraordinary medical placement under RCW 9.94A.728(4).)

ARREST WARRANT DECLARATION

I, Officer Dave Shackleton, of the Mount Vernon Police Department, under penalty of perjury, declare and certify.

This Declaration is an application for an Arrest Warrant charging, ARCAN CETIN, whose date of birth is 08-20-96, and who resides at a last known address of 945 N. Oak Harbor St. Oak Harbor Wa. with the crimes of Murder 1 RCW 9A.32.030 (5 counts) and is supported by the following facts.

On September 23, 2016 at approximately 6:53 p.m. witnesses reported to Skagit 911 that there was a shooting at the Macy's Women's store in the Cascade Mall, 700 Cascade Mall Dr., Burlington, WA 98233, in Skagit County. Callers reported that one possibly Hispanic male dressed in grayish clothing had entered the store with a long rifle and fired multiple shots. Numerous people had been shot.

Law enforcement officers and medical personnel from multiple agencies arrived on scene and began clearing the scene. Upon entry into the Macy's Women's store officers located one juvenile and four adult victims. The juvenile victim and three of the adult victims were deceased. One male adult victim was transported to Harborview Medical Center and was later pronounced deceased.

Witnesses reported that they were at the mall and observed the suspect remove a rifle from his trunk. They described the car as a blue four door sedan that appeared similar to a Kia or a Hyundai. They said that there was a dent on the rear drivers' side quarter panel.

Detectives obtained surveillance video from inside the Macy's Women's store and from the Cascade Mall that showed the suspect arriving at the mall and walking into the Chucky Cheese entrance, going through the mall, and then exiting the Macy's Women's store west entrance. The suspect goes to his vehicle, moves it closer to the Macy's Women's store west entrance, gets the rifle from his trunk, then enters the Macy's Women's store through the west entrance. He was inside the store for approximately one minute. During that time, the suspect initially shot the juvenile victim near some clothing racks, and then walked through the store toward the cosmetics counter. He encountered and shot the adult male victim, then shot three adult female victims. The suspect placed the rifle that he used on top of the cosmetics counter, exited the Macy's Women's store through the west entrance, got into his vehicle and then left the store. The suspect was wearing a dark colored t-shirt and shorts.

The video showed the suspect vehicle travelling northbound on Burlington Boulevard near Cascade Place. The vehicle was last seen on video near Burlington Boulevard near Fairhaven Avenue.

The rifle that was used in this incident was identified as a Ruger 10-22 that had a 25 round magazine in the magazine well.

Details of the incident, along with still photographs of the suspect that were obtained from video were released to the media. Detectives started a tip line to receive tips from anyone who may have information that could be related to this case. Detectives obtained a tip from a witness that



stated that the person in the photographs appeared similar to ARCAN CETIN. One witness provided photographs and stated that there was "much resemblance" to CETIN.


Detectives also obtained information that CETIN worked at a gym in Oak Harbor. The detectives went to the gym and interviewed several employees. They were shown the still photographs of the suspect and they stated that it did appear that this person was CETIN.

Detectives went to ARCAN CETIN'S father's residence in Oak Harbor. His father reported that CETIN was closer to his mother. He advised that he and CETIN had a falling out recently. CETIN'S father said that he had dinner with CETIN about 4:30 p.m. on September 23, 2016. CETIN was supposed to go to work that night, but his father has not seen him since dinner. CETIN left, saying he was going to work. He also stated that he was his Ruger 10/22. He was also missing .22 ammunition. CETIN'S father also stated that CETIN drives a blue Chevrolet Cavalier and stated that it had damage to the drivers' side rear quarter panel near the fender. *missing*

Detectives contacted CETIN'S mother. They showed her still photographs of the suspect and she positively identified CETIN as the person in the photographs. She provided CETIN'S address as 945 N. Oak Harbor St. Oak Harbor Wa. #M205. CETIN'S mother told detectives that she and CETIN'S father help him pay rent at the apartment and that she visits him there on a regular basis. CETIN'S mother states that she was last at the apartment on Wednesday, September 21, 2016.

On September 24, 2016 at approximately 6:20pm, officers contacted CETIN in his 2005 Chevrolet Cavalier approximately one block away from his residence and took him into custody. During CETIN'S arrest, he was found to have a satchel that contained a laptop computer. CETIN'S said that his father had purchased a laptop for him. During a post Miranda interview with detectives, CETIN said that it was him in the video and he did bring the rifle into Macy's and shot all 5 victims.
