But it seems to me that you were sending, there was a message you wanted out in all of this and that's why this happened. So you know and it, and it's your chance to let that message be known. Well we're talking about, we're talking about the incident that happened up at 29th and King you know that. With the two guys and the, from the car, from the club downtown Pine, up on Pine Street. Ok. We got, let me tell you right up front. Your fingerprints are all over the inside of that car. We've got you on video walking with them to the car. It's not an issue. We didn't have to come out here and talk to you cause that doesn't matter. We don't need you to tell me anything. But that's a done deal. It's a done deal. So, but that's but again you you're it seemed to me that you were making a statement and and maybe it's about Islam, maybe it's not. I don't know. That's what I'm here to find out. You know. So we know, we all know what happened. We know about how you guys hooked up. We know about meeting outside the club. We know about walking to the car. And we know you know that you drove away in the car. Some people saw you out there, when you picked up the hat. Threw the hat, people saw that. They saw you. We got you on video. You left your fingerprints on the inside of the car. Ok. That's how we got your name in the first place. In the backseat, where you were sitting right behind the driver. You went, your palm print was on the, on the window. Like you must at some point pushed up and put your palm on the window. I don't know, but that's what we got so it's not you know. There's no issue in this case. It's not like oh let's go see if Muhammad will tell us what happened so we can nail him. Oh no no it's not about that at all. Cause I mean it's a done deal. That's a done deal. You're already charged in that. I don't know if you know that. The people, it was on the news and I'm sure your family told you. You're already charged, formally charged with two murders in Seattle, ok. It's not an investigation anymore, but again, we want to give you as a man, a chance to tell us what happened from your point of view and if there was a message you were trying to send we're here to hear your message. You know? It seemed to me that's just in my experience. I've been doing murders for twenty years now. I've been a policeman for thirty-five. And I see a lot. And yours was different. I said this guy is trying to tell people something, ok? That's what this is about, and I think you know what I'm talking about maybe I'm, maybe you're reluctant to tell me what the message is. I don't know. But if you're a true believer in the message, then you got to get the message out. That's all I gotta tell you. Maybe it's not anything I'm thinking. Maybe I'm completely wrong, but you can tell me that if I am.

I mean it's not like we can, we didn't. We're not coming here trying to bullshit you. I'm telling you right up front.
