**STIPULATED REQUEST FOR REMOVAL ORDER**  
**AND WAIVER OF HEARING**

**PETICION ESTIPULADA PARA LA ORDEN DE EXPULSION**  
**Y RENUNCIA DE AUDIENCIA**

I, Abdullah ALNOSHAN a/k/a Abdullah ALNOASHAN, a/k/a Abdullah ALNUSHAN, Respondent, herein make the following requests, statements, admissions, and stipulations. I understand that I am in removal proceedings and that by signing this document I am requesting a prompt order of removal from the United States.

Yo, \_\_\_\_\_, el/la demandado(a), por la presente hago las siguientes peticiones, declaraciones, admisiones y estipulaciones. Comprendo que estoy en procedimientos de expulsion/remocion y que al firmar este documento, estoy pidiendo una orden pronta de expulsion de los Estados Unidos.

1. I am at least 18 years of age.

*Tengo por los menos 18 (dieciocho) anos de edad.*

2. I have received a copy of the Notice to Appear (NTA) dated August 2, 2005, and my full, true and correct name is as stated therein. (See NTA previously filed).

3. I have been advised of my right to be **represented by a lawyer** or other person qualified to represent aliens in immigration proceedings at no expense to the Government of the United States. I have also been provided a copy of the List of Free Legal Services Providers. (Circle "a" or "b").

4. I have been advised that by signing this request, I will be giving up the following legal rights that I would have in a hearing before an Immigration Judge.

- a. The right to question witnesses;
- b. The right to offer and to object to evidence;
- c. The right to require the government to prove my removability.

Knowing this, I waive these rights and request that my removal proceedings be held without a hearing and that the Immigration Judge issue an order based solely on the written record.

5. I admit that all of the factual allegations contained in the NTA are true and correct as written, and concede that I should be removed from the United States based on those charges.

6. I have been explained my eligibility or ineligibility for relief from removal and the benefits for which I may be eligible including, but not limited to, voluntary departure, asylum, withholding of removal, adjustment of status, registry, de novo review of a termination of conditional resident status, de novo review of a denial or revocation of temporary protected status, suspension of deportation/cancellation of removal, or any other possible relief under the Act. It has also been determined that I do not have derived or acquired United States citizenship.

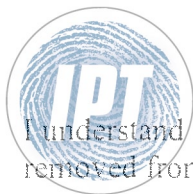
10. I request that my removal from the United States be based solely on the stipulated order. By signing this stipulation, I understand that I am giving up the right to appear before an immigration judge and that I will be removed from the United States without a hearing.

I may also be inadmissible for a period of 20 years or barred completely from admission to the United States.
