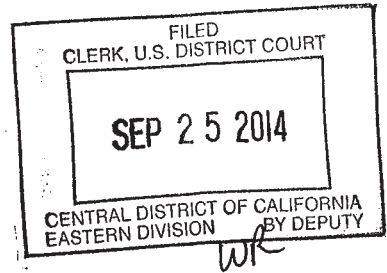

1 **COUNT ONE**

2 We, the jury in the above-captioned case, unanimously find
3 defendant Ralph Kenneth Deleon:

4 X **GUILTY** _____ **NOT GUILTY**

5 of conspiracy to provide material support and resources, namely,
6 himself and his codefendants, in violation of Section 2339A of
7 the United States Code, as charged in Count One of the Second
8 Superseding Indictment, knowing and intending that he and his
9 codefendants were to be used in preparation for, and in carrying
10 out, violations of one or more of the following federal law(s):

11 X (1) Section 956(a) of Title 18 of the United States
12 Code, which prohibits conspiring to kill, kidnap,
13 or maim a person at a place located outside of the
14 United States;

15 _____ (2) Section 1114 of Title 18 of the United States
16 Code, which prohibits killing or attempting to
17 kill an officer or employee of the United States,
18 including members of the uniformed services, while
19 the officer or employee was engaged in or on
20 account of the performance of official duties;

21 X (3) Sections 2332(a) and (b) of Title 18 of the United
22 States Code, which prohibit killing, or
23 attempting, or conspiring to kill, a national of
24 the United States while the national is outside of
25 the United States.

7 organization, in violation of Section 2339B of Title 18 of the
8 United States Code, as charged in Count Two of the Second
9 Superseding Indictment.

2 We, the jury in the above-captioned case, unanimously find
3 defendant Ralph Kenneth Deleon:

4 X **GUILTY** _____ **NOT GUILTY**

5 of conspiracy to commit murder, kidnapping, or maiming outside of
6 the United States, in violation of Section 956(a) of Title 18 of
7 the United States Code, as charged in Count Three of the Second
8 Superseding Indictment.

7 States Code, as charged in Count Five of the Second Superseding
