JOINT STATEMENT REGARDING PENDING MOTIONS IN LIMINE AND STIPULATIONS

NOW COMES the United States and Defendant Rasmieh Odeh, through their counsel, and for their Joint Statement Identifying Stipulated Facts and Issues, state:

- 1. On August 15, 2014, the Court ordered the parties to file a Joint Statement "identifying any issues that have been resolved and any agreements reached concerning disputed facts." *See* Docket Entry 85 (order).
- 2. The parties have conferred. As to the government's motion to Exclude Evidence, Argument and Jury Instruction Relating to Consequences of Conviction (Docket Entry 74), which sought an order prohibiting the defendant from raising before the jury any of the possible criminal penalties applicable to the offense charged, 18 U.S.C. § 1425(a) (up to ten years

imprisonment and a fine of up to \$250,000), or the provisions of 8 U.S.C. \$ 1451(e) (requiring the Court to enter an order canceling the defendant's certificate of naturalization in the event of conviction under 18 U.S.C. \$ 1425). Defendant will stipulate to the entry of an order granting the requested relief. *See* E.D. Mich. L.R. 7.1(a)(1). If the Court wishes, the government will submit a proposed order to that effect.

- 3. The government has pared down the list of documents received through Mutual Legal Assistance Treaty which it will seek to offer. By way of background, pursuant to a Mutual Legal Assistance Treaty between the United States and Israel, the Department of Justice received approximately 1,500 pages of documents from Israel. Those documents relate to defendant's 1969 arrest and subsequent trial in Israel for two bombings. The documents include police reports, prison records and transcripts of court proceedings.
- 4. The MLAT documents include defendant's confession given to Israeli authorities. Defendant Odeh previously objected to trial transcripts which admitted her confession to Israeli authorities, on the ground that her confession was the product of torture and its introduction in a U.S. court would constitute a violation of Due Process. While the government disagrees with that position on factual and legal grounds, it has sought to

narrow the issues before the Court by reducing the list of documents produced under the treaty which it seeks to admit at trial. The narrowed list of documents which it seeks to offer at trial, with a description of each document and its Bates numbering is attached as Exhibit A, and previously was provided to counsel for Defendant Odeh. Each document is either an authentication document, a document identifying defendant such as a fingerprint card, or a document relating directly to defendant's arrest, charge, conviction or imprisonment. Defendant Odeh's confession and her "pointing out statement" in which she showed authorities the site of the bombing are excluded and will not be offered by the government at trial.

5. The remaining MLAT documents, which the government does seek to admit, relate to defendant's arrest, charge, conviction and imprisonment. No further stipulations or narrowing of issues are possible with regard to those documents, and thus the Court will have to rule on their admissibility. This is so even though defendant previously stated that "defendant concedes, and will not contest at trial, that she was arrested by the Israeli Defense Forces, convicted by an Israeli military court and imprisoned in an Israeli prison," (Docket Entry 62: Response By Rasmieh Yousef Odeh Re Motion In Limine To Exclude (1) Evidence Relating To Claims Of Innocence Of Underlying Foreign Convictions And (2) Allegations Of Torture, Page ID 544 et seq.).

Defendant states "It is the defendant's position as stated in her motion in limine, that all documents created by the Israeli military occupation legal system which operates in a manner inconsistent with American concepts of fundamental fairness and due process are not credible or legitimate and should not be admissible in a U.S. court for any purpose. If the Court allows some or all of such military occupation documents to be admitted, the defendant may not object to some of these documents, but at present she is not prepared to stipulate to their admission or to the facts which they are offered to prove." It is the government's position that the scaled-down list of documents are properly authenticated under the Treaty, and are relevant because they relate to defendant's arrest, charge, conviction and imprisonment in Israel; the indictment alleges that defendant falsely answered on her naturalization application questions asking her whether she had ever been arrested, charged, convicted, or imprisoned. See Indictment, General Allegations, ¶¶ 23-26. Thus, the Court will have to rule on the remaining issues of admissibility as to the documents listed in Exhibit A, which includes their authenticity and authentication as well as their translation into English.

6. No other stipulations or narrowing of issues has been agreed to at present.

Thus, still outstanding issues which will have to be ruled on by the Court

are: (A) Defendant's intention to present expert testimony regarding Post Traumatic Stress Disorder and associated issues of whether 18 U.S.C. § 1425 defines a specific intent crime and, if it does, whether defendant's proffered expert testimony is admissible to negate intent; (B) Defendant's motion to preclude use of the word "terrorist" or "terrorism" before the jury; (C) Defendant's motion to preclude mention of the specific charges of which she was convicted in Israel; and (D) Defendant's motion to dismiss the indictment on the basis of alleged selective prosecution. The government will separately answer the selective prosecution motion. The government's motion to preclude defendant from mentioning or arguing selective prosecution before the jury appears to be moot in light of defendant's laterfiled motion alleging selective prosecution. However, Defendant agrees that she will make no argument to the jury alleging selective prosecution or

improper motivation in bringing the case if the Court denies her motion to dismiss the indictment based on selective prosecution.

One of the bombs exploded and caused the death of Leon Kannar and Edward Jaffe, May Their Memory Be a Blessing, as well as injuries to a multitude of people.





On the date 21.2.69 at approximately 10:50 I was called to Super-Sol [Supermarket] in Paris Circle as there was an explosion. Subsequent to the examination I conducted at the place of the bomb, I assessed that an explosive load the size of maximum three kilogram connected to a delay pencil was placed there. During our survey of the place where it occurred, I was called by one of the IDF Officers to a second corner of the Super-Sol where there was another load intended to explode. When everyone cleared out, I approached the load and noticed a metal candy box containing six Russian explosive bricks. Each brick weighed two hundred gram for a total of a kilo and two hundred gram. One of the bricks was connected a silver colored [illeg] attached to a mechanical delay pencil placed together in one of the bricks. The pencil was tied with a single black ribbon a [Possibly yellow] Russian detonator. Each brick contained regular explosives. The load was neutralized and exited without danger.







THE VERDICT

We heard from the Defense the difficult circumstances of some of the defendants, the children of refugee families. We should comment that whatever the past personal circumstances of each defendant may be, it is fitting that the court not yield to those circumstances, but relatively at large weigh the danger to the security of the public as related to their activities.

In front of us is a group of defendants who for the most part planned and executed attacks on a defenseless population.

Due to the circumstances of the current security situation, the courts need to grant full attention to deter active offenders in order to protect the public.

Defendant no. 1 [f] took a central role in this affair. As for the fourth and seventh part of the indictment - life imprisonment for each part.

All prison charges are to begin from the day of her arrest - .1.3.69.

Defendant no. 2 placed explosives at Supersol with the goal to hurt the people there.

This defendant held in her possession a considerable amount of weapons and other accessories. She made these weapons available to the terrorist organization and was [ill] woman. The operation at Supersol was executed by her after careful planning as the defendant took it upon her to supply explosives for this purpose. In light of her role as number one in this affair, we hereby sentence her as follows:

In the first part of the Indictment (10) years imprisonment.

In the second part of the indictment and the fifth part we sentence her to life imprisonment for each part.

The sentence for all the above is to begin .1.3.69.
