Through my Short experience with AQAP + my research into the religion of Islam, I have come to realize that I was misled. A.Q's action is damaging the image of Islam + I further do not believe They represent true Islamic values. - Please See attached document: "THE HOLY PROPHET'S SUNNAH": This document would show a brief sketch of the Personality of Prophet Muhammad (5) by Sheikh fazlur Rahman Ansaari (1914-1974) who is sheikh Imran Hoseinis eminent teacher who I am very much influenced Since my return from Yemen. The 911 attack was literally unbelievable, + many muslims hold the view that it was an inside - conspiracy Since they Could not believe any muslims would do Such. I am convinced that it was an att actual attack that was planned + carried out by some Muslims under DSAMA BIN LADIN. I would personally Condemn Such a Shameful + provocative act + I also believe That any Muslim with a Sound mind + belief would never carry out nor praise such attacks. I blame myself for my involvement with AGAP: I was very naive, There were many shortcomings in my thoughts + I was ignorant of the Law. I was deluded by the prevalent misleading propaganda over the internet + my poor knowledge of Islam at the time has also Coatibuted to my erroneous judgment. My intention was purely to help fellow Muslims who were hurt by wars or deprived of Tights from by tyrannical leaders; I have always been or try to be a helpful person, + my views have always been different from that of A. Q. The fact that I've Sent a laptop to Bangladesh ( a Copy of the Media Content + The instruction pdf is available for all to see, not a single Al-QAIDA or FMAM ANWAR AL-AWLAQT Material is to be found) for the Soul Sole purpose of establishing a Muslim Village, an idea which was base on Sheikh Imran Hosein (a Sufi Sholar)) Call to preserving faith in the LAST-AGE,

This Step which I have made would in fact, amount to leaving A.B ideology.

I was aware of this + was Gomfortable with this decision before my arrest in DEC 2011. This project was a Continuation of a long term goal my wife + I have been working on.

4nd I not been arrested, at some point in the near future as my Children have grown up, my family + I would have migrated to Bangladesh to Start a new life away from Sectarianism + to escape Islamic phosia provoked by a number of factors which includes angry Muslims.

I have lived as a Secular person for most of my life + have integrated well into the British Gulture ever since I was able to Communicate in English; one of the most attractive aspects of London is the Sheer diversity in Gulture + ethnicity which I have always experienced + enjoyed, this is why I have Chosen "SHATTA STUDIO" as a Company name for my freelance business since 2007. The word "SHATTA" is an Arabic word for diversity. My method of work was to Combine western + Eastern art. I was never a fan of books until College, prior to my conversion I have always taken interest into nature, film + music, + It was where I find much inspiration.

I Still keep in Contact with old friends, I have also invited many to my wedding in MARCH 2010, + as a muslim, I have also taken part in the "STOP THE WAR COALITION" rallies alongside with non-muslim activist around 2006-7 + have always known that there are millions of non-muslims who would stand up against wrong doing around the world in peaceful rallies regardlers of the faith or ethnicity. I have seen footages of thousands of brave British + American civilian rallying against the vietnam war long before my conversion. Footages of young men t women including vietnam Veterans beaten to the ground t bloodied in protest against the war. My former Lawyer MR STEVEN FRANLIN who is a Jew have personally bld me himself that he have attended some of the VIETNAM ANTI-WAR rallies in his College years.

There are many great works from Aid, + Peace Activist organized around the world which I could have taken part in rather than A.Q. in fact; I only became aware of the term "CLIMATE WARRIORS" after following the "DEMOCRACY NEW" Raidio Show while in the US.

I obviously legist having been associated with Terrorism + I obviously did not see the Severity of the Consequence at the time + I am now very assamed, particularly for playing any part in distorting the Islamic faith.

#### BACKGROUND

I am the first born Jon in the family of 4 + growing up was very difficult especially when English is not the 1st language + my parents were poor + uneducated which makes learning + integrating more difficult.

I remembered I would at times miss out on sport activities Such as swimming serause my parents doesn't understand that I've required spare swimming kit, upon leaving Primary School, I've ended up being admitted into a Secondary school almost 2 hours from home because my parents left The application too late, I was around IO-11 year old at the time + had to wake up around 6 am to for school For almost a year before I was then transferred to a local School.

### S CHOOL + EDUCATION

Being small short + Asian with a broken English accent + a refugee, I was bulled + beaten on numerous occasions growing up. The 1st secondary School I've affected, I was once punched on my cheek so hard which caused such a bruising that both of my parents had to drive to shischool. My parents + I couldn't do anything because we weren't able to communicate. The most serious incident was when I was transferred to a local Sch; I was punched against the wall + was hospitalized + had to be x-rayed, Portunately, no Surgery required, my parents rushed to the hospital. I felt bad for them to see me hurt.



As I grow up + learnt English I was then able to help my parents + other vietnamese families with interpretation. I would most often have to attend mums doctors + hospitals appointments, shopping + translating letters.

Due to my language problem I was unable to learn effectively in School,

I didnit do well in my Gore Subjects but excel in art. My parent Couldnit see

only future in me for learning art + would most often be very discouraging.

Eventually when I've left school with a good artistic skill I was then able to

enroll into Gollege + pursued advance studies in Graphic + Art in 2000 - 2002.

Having passed my A-Levels Program in Lewisham College (London), I was

Then eligible to enroll on a degree Course at Ravensbournes Design Queste

in S.E London. It was here in 2004 That I embraced Islam.

## 2004 - CONVERSION TO ISLAM

Prior to Conversion I was going through depression due to Stress, night Clubs, drugs + 91 chol- I was spending most of my Students loans on Gate Cannabis + trance + techno parties. I've started smoking when I was around 11, cannabis around H, when I was 18 up till my conversion to Islam age 21, The Cannabis + parties became more regular. I Gate feel notice the Cannabis was affecting me psychologically; I was losing a lot of memory + Ganfidents, stuttering in my speech + had a poor mood + would often have negative + depressive thoughts + I was wasting a lot of money. I kept most of this from the my parents. Islam came at the right time.

I converted after making a simple enquiry about Islam to a muslim classmate, he gave me a few books + it took me a week to be convinced. I telt enlighten by the beliefs system + the way of life it has to offer - the brother who helps my conversion is called British bern moroccan student in London. He was the same age about the same age as me + is not so much religious but was very well mannered + sincere. We drove to his central mosque at REGENTS PARK + it was where I've taken the testimony of faith (the SHAHADAH), I was 21 years of age.

### TABLIGHT TAMA'AT (TJ)

After Conversion, I've immediatly gave up smoking, all intoxicants + night clubs. I really felt reborn + wanted to Start Fresh. I then attend. The local mosque (old Kent Road). Met some youth who was active in ATJ, (Islamic outreach + reform movement originated in India in the 2015). I've began by participating in their gatherings at the mosque + their Centre (Makaz) in WESTHAM LONDON. Around a few months after Conversion. I've decided to take part in their 40-days program out of LONDON to attend The UK Centrat TJ gathering in WEST YORKSHIRE + From there to their Outreach trips, Covering over 12 Mosque around North of England + wales, learning Islam with

Some of my local brothers + others from all over the UK.

During the program we would conduct Islamic classes, make outreach to the local muslims + encourage each other towards 3 basic principle; cearn, Practice + teach
The main focus is to develop Islamic Spirituality Through learning faith + Sqcred deeds.

In around the Spring of 2006, I decided to participate in a Four-month program to India and Bangladesh to learn more about TJ. We would stay at a Mosque for a few days + move to another. During this trip I may have Covered over 30 Mosque, mostly in India + in particular in Mumbal city where I've spent much of the time. The program was similar to the UK 40-days trip accept that it was much more active + rooted + many members were very experienced + knowledgeable. The Scholars were exceptional + very wise. This was my 1st ever trip overseas without my family. It was a really spiritual + a once in a life-time experience, I was moved by the sheer poverty + became more concern with helping to heal the world. I felt like a young Buddha. The hardships of travelling + living amongst the locals really develop + andition me mentally + physically, not once did we spend a day in a hotel. 4 months of sleeping on the floor + wearing simple traditional dress, a carrier bag + living like a traveler.

when I've return to LONDON. I've fell like I've just return from pilgrimage, religiously focus, a strong sense of selflessness + a greater Garcon for others + a preference for a simple life. I was committed + wanted to devout my self to humanitarian course + helping people in whatever way I could, This was one of the fruit of TJ; "love others as much as you love your own family".

SUMMER 2009

I once met a big white elderly man at a local Mosque in NEW CROSS, he was around 60 years of age, the was very educated to claims to be a former christian priest. He said he Gonverted to Islam in Kenya there outcaste by his Community. He said he just return t is in desporate need to refrieve his properties at padding instruction, I offer him to stay at my address until he resettles. Beside his property issues he also claim to suffer from many health Complication, in fact, in one of the days at my address. I had to drive him to a local hospital for diabetic insulin. I was living by myself at the New address at the time. He seem very warm the gravine, he ask to borrow too pounds until he Guld sort out his account. He stayed at my address for a few days. I trusted him to the extent that I've left him home with the keys. I return one day t found him absent t so was my sony offital Ser camera that I've recently brought for over 300 pounds. It was one of the worst experiences I we ever had in my life: I would sit to stand motionless the was confuse, "how could someone do this?" I ask my self.

I really felt like an idiot to have placed so much trust to strangers, I was also paranoid for some days + had the locks changed.

### 2010-HELPING FRIENDS WITH MARRIAGE

I have a Vietnamese friend called who was also a muslim Gonvert. He was a Couple years elder than ±. At some point I've introduce him to a muslims matrimony website Called "Muslim-Introd", he would often ame around + Stay over at my new home to work on his profile + Search for a Spouse online. He eventually found a caribbean American sister in Boston. He then flew there + married her in 2010. I think in around 2011-12 while ∓ was in prison, she came over to London to meet his family + I think they are planning to settle in London. Around the same time, I had another friend Called he was a tall Somali Scother with a Cheerful face. He was staying in LEEDs at the time which was a 6-Hours drive from London. He was about to marry a sister + wanted some one to drive him to London, he had a lot of properties + the public transport masout an option. ∓ didn't he sitate to offer my help + 30 I drove up LEEDs + did what I Guld. Some weeks later he invited me to attend his wedding; all this was just before I left for Yemen in Dec 2010.

# EMPLOYMENT

my first ever poid job was working at a McDonald Restaurant. I Started in The kitchen + progressed to Cashiers. I have worked in 2 McDonald Restaurants, One in CAMBERWELL + The other was in DEPTFORD closer to home. I have worked altogether for almost 2 years before leaving to start Gollege in SEPT 2000.

After leaving Glege Ive Started working in various Print Shop designing advertisements. I have also worked as a free lance graphic designer under my registered Company Called SHATTA STUDIO. I have also taught graphic design at a Turkish Community School for Several months to tecnagers. As it was an evening class, the Contract was brief.

Due to my experiences with working with the Emmunity. I was offered to work as an outreach worker for REETA (Refugee, Employment, Education. Training the Advice). This was around 2005-07. It was a very rewarding role as I was able to teach basic Computer this search skills the give advice the guidance to predominantly refugee clients from the somality vietnamere background. I was later offered a more secured confract in 2010, about a Couple of months after my marriage in a similar role at MI-solution, based in DEPTION.

She is very under Standing, a devout muslim t a very forgiving wife: I would never exchange her for anyone else + She have expressed the same feeling. In fact, she has written in her recent lefter: "Minh, I have no intention of remarrying. I have no desire to be with some one else; + I pray Allah sas not written down another person for me in the book of decree... " (I feb 2006. Lefter). Not many women would wait for their spouse who is serving lengthy sentences, by Allah's grave, I believe my wife much love for me would cause her to do so, + I could only imagine the bardship that she will be facing without me.

when I've returned from YEMEN. The very 1st thing I did was to apologize to her for leaving mithout her Gorsent + for not being able to respond to her emails while in YEMEN, additionally I have also made many efforts to reform myself. I didn't give enough thought at the time + didn't see the wider Gorsequences, I felt it was a religious obligation + was compelled, I was obviously wrong for leaving my wife in such circumstances + particularly to Join A.D. As a husband, I was directly responsible for granting guarding + providing for my family. I know now what I did not know then that my action was a major violation of her rights.

from July op fill my arrest, we both continued with the MUSLIM PROJECT + further our plans for it to be realized. We've sent a laptop loaded with heaps of educational materials to initiate the idea to her Gusin SACHI currently reside in a village in BANGLADESH where we have planned to migrate in the near future.

I was arrested on deportation Charge in DEC 2011 literally some weeks after we've sent the Laptop. I was arrested without any criminal charges + was taken into a High security Igil in S.E. Landon where I Spent around 2 years before being transferred to a prison 3 hours outside of Landon. visits become difficult for family ever since.

## HEATHROW AND CASH

The leason that I was untruth ful when I was intercogated at the HEALTHROW AIRPORT is because I was afraid of the Consequences, such as being arrested, imprison, extraditable to the US + torture, I wanted to return home to my family + leave AQ, I never thought that I will ever be arrested since I have not done anything in the UK nor was I planning to. It was just the fear factor + not wanted my family to know that I was involved in terrorism. I didn't have much choice but to hold on to the Cash until I felt that I was safe in the UK. I knew that I once I was dropped off by the brothers to a nearby city in Hadramault, I am expessed to the YEMENI Security forces + may have to pay them off if intercogated. Once I passed over to Bahrain through transit I was then arrested the my proporties including my Cash was seized. After the Two-Day of intercogation they seturn it to me as I was entering the plane. I didn't see the point in dropping the Cash Since I assume that the British Security was already informed to would be ready to arrest since I assume that the British Security was already informed to would be ready to arrest me, my guess was right. I was picked up literally as Soon as I placed a foot off the plane by the exit walk way. I was questioned for almost 6 thours + my cash was seized.

# OATH OF ALLEGANCE

I do admit that I have made an oath of allegiance to AQAP through a local Ameer in ABYAN (IAN 2011). The Short oath was Conducted in the open desert along with my Friend SAMI. I was asked to repeat the lines after the Ameer in full Arabic without translation; hence I would not know exactly what I was saying. I assume that the oath is a general statement for one-self to Commit to the rules of the Islamic Community by listening + obeying - As a muslim, I am required to obey the Ameer So long as it does not go against the teaching of the Quran + Sunnah.

Shk. Imran have said: [ The members of the Jama'ah have a religious obligation to obey the Ameer Jo long as it requires no disobediance to Allah (SWT) + His Prophet CSAW). "Listening + obeying" is located at the very substance of the Islamic way of life.] (Source: One Ameer one Jama'ah @imranhosein.org).

Throughout my Stay with ABAP, I have never met The principle Ameer (ABU BASEER).

My English was poor to do not understand the Philosophy of Arthur well enough to propagate Credibly. Realizing this, Samire provided me with hours of tutorial material for me to train on video Editing (ADOBE AFTER EFFECT) which is what I was essentially working on for the most of my Stay with Samire. Considering that the area where we stayed was poorly powered, electricity was short lived as it was the height of the Civil war, in most asses we Guld only work for a few hours per day.

#### CONFLICT WITH SAMIR KHAN

My poolest relation while in YEMEN was with SAMIR. We have much disagreement thave argued on numerous occasions, most was petty but there was one occasion when I will to defend TJ, I was verbally attacked + Scorned; it so happen that it was on the day that CWI was present. He had to intervene + separate me from SAMIR + advise me to not speak to him. this was around March/April. SAMIR is heavily influence by ARP ideology + Strongly opposes TJ, Sufi + Shk. Imran Hosein version of thoughts originate.

On March 1, 2015, United Kingdom citizen MINH QUANG PHAM, also known as (a.k.a) MUHAMMAD AMIN PHAM, a.k.a. AMIN (hereinafter referred to as PHAM), date of birth place of birth Vietnam, United Kingdom passport number: was voluntarily interviewed in New York. Federal Bureau of Investigation (FBI) Special Agents (SA) and conducted the interview. The interview began at approximately 10:40 a.m. (Eastern Standard Time; EST) and concluded at approximately 3:30 p.m. (EST). After being advised his rights (FD-395) and his rights to a speedy presentment, PHAM waived his rights and provided the following information:

At an unspecified date prior to mid-June 2011, PHAM approached AULAQI and offered to conduct a suicide attack and "sacrifice himself" on behalf of al-Qaeda upon his return to the United Kingdom (UK). PHAM told AULAQI that he would need approximately 4000 GBP to carry out the attack. AULAQI ultimately gave PHAM approximately 6000 GBP in case PHAM had any unforeseen expenses during his attack preparation. PHAM planned on using the money to rent a house in the UK to construct the explosive device and to purchase the chemicals and other materials needed for the attack.

In preparation for the attack, in approximately mid-June 2011, PHAM received one day of training on how to make explosives and an explosive device. The training was provided by AULAQI at a house located approximately a half an hour drive from the Marib, Yemen-based house in which PHAM had worked on Inspire. During the training, AULAQI showed PHAM how to mix chemicals to make an explosive powder. PHAM then proceeded to make a small batch of a white powdery explosive material

approximately a few feet away from the device and tin can when he detonated the device. The explosion generated enough force to launch the tin can away from PHAM and into the air.

PHAM explained the steps AULAQI taught him and that he used when PHAM constructed and tested the small device during training. It was the same process PHAM intended to use for creating the explosive powder and the device when he returned to the UK. The chemicals to be used to create the explosive powder consisted of

PHAM could not recall the exact amount of each chemical that would be needed nor the steps to mix the chemicals. Once they were combined and dried, however, they would produce a white explosive powder. To ignite the explosives, PHAM

AULAQI had also instructed PHAM to tape bolts around the container to act as shrapnel when the device was activated.

PHAM stated that the instructions to create the explosives and device he was to make were published in Inspire and, if he had forgotten the steps, he could have referred to that edition of Inspire for reference. PHAM did not travel back to the UK with any bomb making instructions.

AULAQI instructed PHAM to target the Arrivals Section of Heathrow International Airport. In particular, PHAM was to target arrivals from the United States or Israel. AULAQI left the exact date and time of the attack to PHAM's discretion. PHAM intended to conduct the attack by concealing the explosive device in a backpack. AULAQI did not provide PHAM any alternative attack locations. PHAM is not aware of AULAQI instructing any other al-Qaeda members to conduct attacks in the West.

Upon PHAM's return to the UK, the money AULAQI provided PHAM for the attack was confiscated by the authorities. PHAM was aware that his mother kept money in her home that could be used to fund the attack, but PHAM never attempted to take his mother's money. PHAM also noted that he had access to acetone through the nail shop that his sister operated, but he never took anything from the shop either.
