My trial is over in the Federal level but I still have a pending trial in the State of New Jersey. ALLAH is with me and ALLAH is the best of planners. For my Federal case it was all a publicity to make a mockery out of me. Behind the cameras, I argued that I didn't kill anyone, and brought about a case where 2 people knowingly went into a fight, with one of the person eventually Dying. The case was taken to Court Trial the person who killed received a 27 year sentenced.

With me they offered Life sentence from the beginning I said a person who kills received 27 years, while I didn't, and am receiving Life?? The reply was when this person gets out after 27 years they will have changed and regretted what they did. With you it's an Ageedah Issue. We cannot take it out of you and after your in your 60's when you come out you will continue to carry this Ageedah. So I wasn't going to sign to life and they wouldn't give a Number for Plea.

As trial was coming to an end they gave me time to think about if I wanted to take the STAND in my Defense

I wanted to make a statement but decided not to. I made a Dua, My statement to ALLAH was My Judge is a kaffir, My Lawyer is a kaffir, My Prosecutor is a kaffir, and my Jury are all kaffirs. Who among them will understand the Muslim problem. Their hands are already drenched with Muslim Blood and how will they understand our Struggle. So my Dua to ALLAH was. That on the Day of Judgement you bring back together with everyone from this Court Room, then I will give my statement. Where ALLAH will be my Judge.

My wife Alhumdulillah is Muslim. I pray for her alot, she is a great mother to my children and my best friend in life. I Love her dearly. I wish to reply to you all through E-mail but for now I'm in Solitary Confinement. This is my only way of communicating with you Guys.

May ALLAH Grant you all Hidaaya. May ALLAH Accept your Good Deeds. May ALLAH Protect you All. May ALLAH protect your Family and children. May ALLAH Bless you all. May ALLAH bring us together in a better place. Your work your thoughts really has a great impact on the muslim prisoners here. I Love you All for the SAKE of ALLAH. Insha ALLAH, ALLAH will release me and the muslim prisoners. Our home is in JANNAH Not in the Confinement of these Metal Brick walls.
