

The conditions that our beloved country is currently experiencing require us to think carefully and look for any solution that would let us emerge out of this crisis stronger than we previously have been.

There is no doubt that what Syria is currently undergoing is a clear, well-known, and premeditated matter. Also, there is no doubt that all the leaders and people who love Syria are aware of what is going on and are vigilant of what is being planned.

For this reason, it is indispensable to defend this great country, and to adopt all that is needed to thwart any attempt that intends to harm it. Every Syrian, loyal to his country and believes in its leadership, does not doubt for a second that disposing of dissension is a must and should be decisive and <u>prompt</u>.

On the other hand, however, and since one should exercise caution and be suspicious of broadcasting incidents in Syria to the outer world through international media, since this provides the enemy, represented in those murderers, to present an untrue, fake and misleading view that would make the world set eyes on what those murderers want them to perceive; and since Syrian media is not recognized by the outer world as independent; regrettably, no one cares, or views, or listens to what this media is saying, since it is accused of being the regime's voice; for these reasons, Sir, I have an idea that I would like to present you with, since you are the best and most knowledgeable friend.

Briefly speaking, sir, I have a relative who works as a freelance correspondent in U.S. press; i.e. she does not belong to any specific agency; rather, all agencies publish her work as Reuters and others.

She is of Syrian origin, and has a very good reputation. She has purely secular inclination since, in almost all her writings, she denounces religious extremism and political religious violence. She belongs to liberal ideology, and criticizes conservatives' policies in the U.S.

The proposal is as follows:

If she is allowed to enter Syria and cover the incidents there to become a credible viewpoint of the incidents inside Syria, then Syria would open to the world an area where it could see the truth, which would naturally challenge news transmitted through an eyewitness, or a political activist, or a cell phone picture. How?

Sir, this is a war; a psychological, media and military war that seeks to destroy Syria and its political independence. Therefore, let us deal with it in a similar fashion: a Western correspondent that broadcasts exclusively the facts (of course there will be negative incidents in this broadcast as violence, home invasions and arrests ... etc); <u>however</u>, at the same time, given the same weight and coverage, those who are fighting (Jihadists, Salafists and advocates of rigid ideologies) will also be put on air. Thus, negative aspects would become positive and justified. Violence will be justified against them; home invasions would be justified; and arrests would be justified.

Not only that, but all civilized nations act similarly to confront those who are similar to the aforementioned in the U.S., Britain, France, Germany, Russia ... etc.

Thus, in addition to broadcasting feelings of supporters and the public, then broadcasting opinions of protesters whom this journalist <u>would be able</u> to meet and their extreme opinions (if she could not, we should arrange that to her) .. (Remember this is war); hence, those who are broadcasting now are U.S. programs that have credibility. Thus, in the people, and the recipient's, analyses in general, Syria in fact is right, and the government should be assisted to destroy the afore mentioned.

I apologize for going that far with my-ideas, but again this is (war), and not a laughing matter; and, in my-humble opinion, we should adopt any approach or method, following methods of the Americans. For example,

The explosions [UI] that killed (To be explained over the phone)

Such a matter should be fast and prompt ... And certainly Syria could find the justification that kept her from broadcasting the incidents lately.

My Dear Friend,

This is a summary of the most important points given by each speaker today.

1. Sa'id Mujtahid: He was introduced as the one who was credited for having this conference convened. What he said can be summed up as this: After thanking and praising God ... He thanked God again ... He praised God again. God willing, the Syrian people will be victorious. He talked about what they should do to be united, and that the goal of this conference is the goal of all Syrians: The overthrow of Bashar al-Assad. He emphasized the importance for Syrian-Americans to put pressure on their representatives in Congress in order to compel them to make decisions that would cause the President to lose his legitimacy. He thanked Obama, the President of us, the Syrian-Americans, for his support. He declared that the President is no longer legitimate, and that the illegitimacy resolution would be adopted today, and that he wanted everyone to vote on it.

He directed his speech at the guest, **Constitution**, saying: I met Mr. **Constitution** in the past, and I used to ask him for a decisive resolution to be adopted regarding al-Assad. He would always tell me, if you cannot be organized and have a unified voice, we will not be able to help you. This is because every time he talked with Syrians they would be afraid to mention their names. And now I tell him, look around you and you will see that Syrians are not afraid.

He then ended by introducing

He expressed his appreciation and how much he desired to see the Syrians united against their government. He mentioned that he met in the past with members of other communities, Lebanese, Palestinian and Jewish, etc., but that this is the first time that he meets united and organized Syrians. He stressed that he is happy for this and that as long as they ask their U.S. government to help and support them, their government (i.e., the U.S. government) will respond to them and support them. Then he cited an example. In Egypt and Tunisia, the ruling regimes have denied their people freedom, but they obtained it. Similarly, the Syrians will gain the freedom they deserve. He went on to say that the government in Syria does not understand democracy, and that the Syrian government loses its legitimacy due to the way it treats its people. We, as he stated, are clear with regard to what we want from the Syrian government:

- 1. It needs to put an end to violence.
- 2. It needs to release all political prisoners.
- 3. International organizations should be granted entry to investigate.

Otherwise, Syria will be increasingly more and more isolated. President Obama has effectively started to put pressure on the regime, issuing two executive orders placing sanctions on symbols of the regime. This coincided with sanctions that he placed on the regime's ally, Iran.

We, in cooperation with our European allies and under the U.S. leadership, took part

in issuing new sanctioning laws against the Syrian regime on the 29th of last month in Geneva. To date, the Syrian government has refused access to an international investigative team. Unless the Syrian government changes course <u>now</u>, new decrees will be issued. Work is underway to take such measures. He then announced that the al-Assad regime and al-Assad personally bear the sole responsibility for the situation of instability. (This sentence received a long applause and a standing ovation.) When the speaker saw this, he said, "I will repeat this sentence." He repeated it, and again there was a long applause. He reiterated Obama's statement, "Bashar al-Assad could either lead the transition or get out." (There was a long applause and the chant of *get out*, "get out" from the audience.) He then stressed that he personally believes and even admits that al-Assad does not have any intention to change course, and that everyone needs to work together and help the U.S. government to help them in what they are seeking.

He then conveyed a message from Clinton that salutes the attendees for their bravery in organizing this conference. He reiterated to them that they would be the most important ones who will take ownership in the change that will take place.

3. Dr. Walid al-Bunni:

Via screen through Skype from Syria. He thanked the attendees and affirmed his support for them.

4. Haytham al-Malih:

(The presenter mentioned that they were in hiding in Syria and that they do not see their own families.)

Similarly, support, thanks and appreciation are conveyed.

5. Suzan Kawarnah:

She introduced the statement that everyone ought to vote for, namely:

We Syrians adopt the following:

1. Support of the Syrian people's revolution for dignity, freedom and rights.

2. We condemn oppression against all the people, be it against the majority or the minorities.

3. We condemn the actions committed by the Shabiha, and we salute the brave Syrian soldiers who refused to kill the Syrian people.

4. We condemn the Syrian government's propaganda that terrorist groups are responsible for the killing and sabotage.

5. The security services and their actions will not deter us.

- 6. We pray for the martyrs who perished.
- 7. Lifting the siege of Syrian cities, and allowing food and medicine to reach citizens.
- 8. The release of all political prisoners.
- 9. We declare the state that kills its people to have lost its legitimacy.

10. We urge the international community to support the Syrian people in their revolution. We urge Arab states, the United Nations, the European Union and all countries of the world to drop their support for the Syrian regime.

11. We salute President Obama for his support, and we insist that he continue and carry on with <u>swift action</u> (she stressed this phrase and used a strong expression in English, "*Swift Action*") against the Syrian regime and the Shabiha by way of declaring:

A. The loss of legitimacy of the regime.

B. Work toward asking the European Union and Turkey, under the leadership of the U.S., to accuse al-Assad personally of committing genocide.

C. Pressure against the Syrian government to let assistance in.

D. Human rights and humanitarian organizations should be given entry to Syria.

End of Statement

6. Ahmad Qayyas:

He started his speech by saying that the Syrian Revolution is not sectarian and that he is from Dar'a and has uncles who are Alawite. He urged everyone to have a unified vote in adopting the resolution today, to reject sectarianism as envisioned by the regime, and for everyone's call to be for considering the al-Assad regime illegitimate.

7. Dr. Shakwa 'Abbas:

He talked about the suffering of the Kurds over four decades and how they are unified with all Syrian communities. He stressed that everyone should support the idea of regime change. (The attendees chanted "One, one, one, the Syrian people are one.")

Atassi did not speak; rather, he initiated the voting process and the show of hands to denote approval. He then declared the adoption of the decision by the Council. (Long applause)

9. Ahmad Sidawi:

He is a young man from Latakia. He was introduced as someone who took part in the demonstrations in Latakia. He suffered a gunshot wound and fled to the U.S. after all members of his family had been targeted. He did not speak. He just stood in front of the podium, leaning on two crutches. The attendees chanted, "God is Great."

10. Nu'man Shuqayr:

He gave a brief speech, stating the solidarity of the community in Detroit with the Syrian Revolution and with the decisions that will be adopted.

11. Dr. Radwan Ziyadah: (In my opinion, he is the most important speaker.)

He was introduced as the one espousing filing an international case against President Bashar al-Assad. He began his speech by putting down a roadmap on how to get rid of Bashar al-Assad. He explained that the case that is now being filed internationally has two parts.

The First: This includes the success of filing a human rights case in Geneva, and taking up this case by the Geneva Court on the 29th of last month through the support of the U.S., despite the objection of the Arab League and Muslim states and their refusal to take part. This also includes the success

of the case in promoting that what is happening in Dar'a with regard to mass graves and killing amounts to crimes against humanity.

The Second: This includes going to the International Criminal Court in The Hague and filing a criminal case, the goal of which would be to make a decision to criminalize Bashar al-Assad personally. He mentioned that he spoke with Judge Ocampo, the court's Prosecutor, and that he will be meeting with him in The Hague soon. He stressed that Ocampo had said to him that he <u>could not</u> take up or accept a case of this kind <u>unless</u> a decision would be adopted by a national council representing Syrians regarding this matter. Therefore, we have to adopt a decision delegitimizing Bashar al-Assad and then recognize the Syrian Council as a legitimate representative of the Syrian people. He went on to say that the U.S. State Department should assist in a decision criminalizing Bashar al-Assad.

He then mentioned that he would go to The Hague, taking with him the Case of Hala Abdulaziz et al, as well as other cases that were filed in Belgium, France, Spain and England. He asked of the attendees that anyone who has a problem or knows others who have a problem with the Syrian government and want to file a case to come forward.

12. Marah al-Baqa'i:

This was a speech in support of and encouragement to the rebels and a condemnation of the killing.
