ORDER GRANTING THEBLAZE INC. AND GLENN BECK'S ANTI-SLAPP MOTION TO DISMISS

On this day the Court considered the Anti-SLAPP Motion to Dismiss ("Motion to Dismiss") filed by Defendants TheBlaze Inc. and Glenn Beck. (collectively, "TheBlaze Parties") pursuant to Chapter 27 of the Texas Civil Practice and Remedies Code.

After considering the Motion to Dismiss, any responses and replies thereto, any supporting or opposing affidavits, the evidence admitted, and the argument of counsel, the Court is of the opinion that the Motion to Dismiss should be GRANTED. In support of this ORDER, the Court finds that the conduct of Plaintiffs Mohamed Mohamed, individually and on behalf of Ahmed Mohamed, a minor, (collectively, "Plaintiffs") violates Chapter 27 of the Texas Civil Practice and Remedies Code: IT IS THEREFORE ORDERED that the Motion to Dismiss filed by TheBlaze Parties is in all things GRANTED in its entirety.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that all claims of Plaintiffs against TheBlaze Parties are hereby DISMISSED with prejudice in their entirety. Plaintiffs shall take nothing from these claims.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that, in accordance with Texas Civil Practice & Remedies Code § 27.0009(1), TheBlaze Parties are entitled to recover their court costs, reasonable attorney's fees, and other expenses incurred in moving to dismiss this action and defending against these claims, plus post-judgment interest at the rate of the highest lawful rate per annum on such amount from the date of this ORDER until paid. TheBlaze Parties are ordered to submit evidence of their fees, court costs, and other expenses by affidavit within \(\frac{1}{2} \) days from the date of this Order. TheBlaze Parties shall be awarded such other further relief to which they may be justly entitled, at law or in equity.
