ORDER OF JUDICIAL REMOVAL

Upon the application of the United States of America, by Ronald W. Waterstreet, Assistant United States Attorney, Eastern District of Michigan; upon the Factual Allegations in Support of Judicial Removal; upon the consent of MOHAMMAD HAMDAN ("the defendant") and upon all prior proceedings and submissions in this matter; and full consideration having been given to the matter set forth herein, the Court finds:

1. The defendant is not a citizen or national of the United States.
2. The defendant is a native of Lebanon and a citizen of Lebanon.
3. On or about June 19, 2007, the defendant was admitted to the United States as a lawful permanent resident.
4. On or about August 15, 2016, the defendant voluntarily executed a Form I-407, Record of Abandonment of Lawful Permanent Resident Status, as part of a negotiated plea resolution of this matter.
5. At the time of sentencing in the instant criminal proceeding, the defendant

will be convicted in the United States District Court, Eastern District of Michigan, of Count 1 of the First Superseding Information: False Statement to a Federal Agent Involving International Terrorism, in violation of Title 18 United States Code, Section 1001(a)(2).

6. The maximum term of imprisonment for a conviction of Count One, a violation of Title 18 United States Code, Section 1001(a)(2), is eight (8) years.

7. The defendant is, and at sentencing will be, subject to removal from the United States pursuant to Section 237(a)(1)(B) of the Immigration and Nationality Act of 1952 ("INA"), as amended, 8 United States Code Section 1227(a)(1)(B), as an alien who is present in the United States in violation of this chapter or any other law of the United States.

8. The defendant has waived his right to notice and a hearing under Section 238(c) of the INA, 8 U.S.C. § 1228(c).

9. The defendant has waived the opportunity to pursue any and all forms of relief and protection from removal.

WHEREFORE, IT IS HEREBY ORDERED, pursuant to Section 238(c) of the INA, 8 U.S.C. § 1228(c), that the defendant is ordered removed from the United States to Lebanon.
