On or about December 31, 2022 at about 10:10 PM, at the south east corner of 8th Avenue and West 52nd Street; in the County and State of New York, the defendant, being more than eighteen years old, with intent to cause the death of another person, attempted to cause the death of such person and of a third person, and the intended victim was a police officer as defined in subdivision 34 of section 1.20 of the criminal procedure law who was at the time of the attempted killing engaged in the course of performing his official duties, and the defendant knew and reasonably should have known that the intended victim was a police officer; the defendant, with intent to cause serious physical injury to another person, caused such injury to another person by means of a dangerous instrument; the defendant, with intent to cause serious physical injury to another person, attempted to cause such injury to another person by means of a a dangerous weapon; the defendant, with intent to prevent a peace officer, a police officer, registered nurse, licensed practical nurse, sanitation enforcement agent, a firefighter, including a firefighter acting as a paramedic and emergency medical technician administering first aid in the course of performance of duty as such firefighter, an emergency medical service paramedic and emergency medical service technician, and medical and related personnel in a hospital emergency department, a city marshal, a traffic enforcement officer and traffic enforcement agent, from performing a lawful duty, by means including releasing and failing to control an animal under circumstances evincing the actor's intent that the animal obstruct the lawful activity of such peace officer, police officer, registered nurse, licensed practical nurse, sanitation enforcement

agent, firefighter, paramedic, technician, city marshal, traffic enforcement officer and traffic enforcement agent, caused physical injury to such peace officer, police officer, registered nurse, licensed practical nurse, sanitation enforcement agent, firefighter, paramedic, technician and medical and related personnel in a hospital emergency department, city marshal, traffic enforcement officer and traffic enforcement agent;

The factual basis for these charges are as follows:

Deponent states she has observed and reviewed video surveillance and body worn camera surveillance from the above-described date, time and location. Deponent further states said surveillance shows defendant strike three separate uniformed police officers with an object. Deponent further states that officer #1 sustained a lacerations to his head and skull fractures. Deponent further states that officer #2 sustained lacerations to his forehead and was concussed. Deponent further states that officer #3 sustained lacerations to his head and pain to his body. Deponent further states that the crime scene unit recovered a large black knife from the above-described location. Deponent further states she interviewed defendant and defendant stated (in substance): I WANTED TO KILL AN OFFICER IN UNIFORM. I SAW THE OFFICER AND WAITED UNTIL HE WAS ALONE. I SAID ALLAUH AKBAR. I WALKED UP AND HIT HIM OVER THE HEAD WITH A KUKRI. I CHARGED ANOTHER OFFICER BUT DROPPED THE KNIFE AND I TRIED TO GET THE POLICE OFFICER'S GUN BUT COULDN'T.
