PLEASE TAKE NOTICE THAT:

You do not appear to me to be clearly and beyond a doubt entitled to enter the United States, as you may come within the exclusion provisions of Section 212(a)(6)(C), (7)(B), (8)(A)(i) of the Immigration and Nationality Act, as amended, in that

YOU APPEAR TO HAVE WILLFULLY MISREPRESENTED A MATERIAL FACT IN ORDER TO GAIN ADMISSION INTO THE UNITED STATES. [212(a)(6)(C)]

YOU ARE NOT IN POSSESSION OF A VALID, UNEXPIRED TRAVEL DOCUMENT AND YOU ARE NOT EXCEPT THE PRESENTATION OF THE SAME. [212(a)(7)(B)]

YOU APPEAR TO BE AN IMMIGRANT, NOT IN POSSESSION OF A VALID, UNEXPIRED IMMIGRANT VISA AND YOU ARE NOT EXCEPT THE PRESENTATION OF THE SAME. [212(a)(7)(A)(i)(I)]

YOU ARE NOT IN POSSESSION OF A VALID, UNEXPIRED NONIMMIGRANT VISA AND YOU ARE NOT EXCEPT THE PRESENTATION OF THE SAME. [212(a)(7)(B)]

THEREFORE YOU ARE ~~REMOVED~~ DEFERRED UNDER THE PROVISIONS OF SECTION 238 (b) OF THE IMMIGRATION AND NATIONALITY ACT, AS AMENDED, FOR A HEARING BEFORE AN IMMIGRATION JUDGE TO DETERMINE WHETHER OR NOT YOU ARE ENTITLED TO ENTER THE UNITED STATES OR WHETHER YOU SHALL BE EXCLUDED AND DEPORTED. DURING SUCH HEARING YOU WILL HAVE THE RIGHT TO BE REPRESENTED BY COUNSEL AND TO HAVE A FRIEND OR RELATIVE PRESENT.
