He was going to my family homewith my mother and six of my brothers and sisters. He was stopped at a check point. They took him for questioning about me and what he does in the USA. He was insulted after he was questioned. I was detained two times, the first time was from my village in Sept. of 1989 by SLA group where they came to my house and took me along with my two cousins and was detained for twenty days. The incident was announced in a few Lebanese newspaper. The second time was in Tyre in January of 1992 by militia group "Hizboulla". I was at my cousins' funeral who was killed by a planned car accident in a town closed to Tyre in his way to visit his family. |
