

JOINT STIPULATION AND MOTION TO TERMINATE
EXCLUSION PROCEEDINGS

Respondent, acting by and through his attorneys, GARMO & GARMO P.C., by Steven N. Garmo and the INS through its undersigned Attorney submit this Joint Stipulation to Terminate exclusion proceedings.

Stipulation

Pursuant to this pleading, INS and Respondent hereby stipulate:

1. Respondent is a citizen and national of Lebanon, was last ordered excluded and deported by the Immigration Judge on December 14, 1993 and his request for asylum and withholding of deportation was also denied.
2. Respondent filed a Notice of Appeal with the Board of Immigration Appeals on December 27, 1993. That appeal is presently pending before this board.
3. On September 12, 1997, respondent married Angela Georgia Tsoumas, a United States born citizen. On December 29, 1997, respondent filed for I-130 petition which was approved on June 1, 1998 by the INS in Detroit, Michigan. On December 29, 1997, respondent also filed for I-485, adjustment of status which was approved on July 7, 1998.

Motion to Terminate

Based upon the above stipulation, INS and Respondent jointly move to terminate the exclusion proceedings in the matter.
