Bray advises that he is of the Baptist/Unitarian faith and is a member of the Central Baptist Church on Walker Street in the Berkley section of Norfolk. The defendant reports that he attends church services every Sunday and believes in God.

## INTERESTS AND LEISURE TIME ACTIVITIES:

As his voacational goal, Bray advises that he would like to return to college and continue his education with an emphasis in theology with the ultimate goal of becoming a minister. He further advises that after all charges against him are disposed of, he would like to move to Nashington, D.C. and resume his life with his family.

Social and recreational interests include reading, chess, tennis, and meeting, discussing, debating and exchanging ideas with people from broad and diverse backgrounds. Leisure habits include listening to music and playing all types of music on the piano, especially jazz and classical. He also enjoys playing the saxophone, clarinet, flute and oboe. Bray reports that he is a member of the Citizen Society Character Builder Association, The National Association of Television and Radio Announcers, The Black Music Association, Independent Voters League, The Bell Diamond Civic League and is a member of the National Association for the Advancement of Colored People. Bray claims one close associate, Wallace Johnson, a black male, age 40, whom subject has known for ten years. Mr. Johnson is an assistant director for the Norfolk Development Corps in Norfolk and resides in the Green Hill Farm section of Norfolk. Johnson's only known conflict with the law occurred in 1979 in Norfolk when he was convicted of Curse and Abuse in Norfolk General District Court.

Subject advises that in 1958 at the age of B, he underwent eye surgery to remove a blood clot. He recalls no other history of serious illness, disease or injury. Bray considers himself in good physical and emotional health except for reoccurring stomach problems for which he has been hospitalized on two separate occasions in 1981.

Concerning alcohol, Bray advises that he has consumed dinner wine on holidays or on special occasions with parental consent from age 13 until age 18. From age 18 until 21, subject reports moderate use of beer, rum and vodka. From age 22 to present, Bray advises that he consumes sherry and mixed drinks, primarily, gin and tonic, moderately, at meals or when socializing. Concerning drugs, the defendant reports that he started experimenting with marijuana at the age of 18 while attending school at Florida A & M. He further advises occasional use, four or five marijuana "joints" on an irregular basis, primarily on the weekends, until his arrest for the instant offense. Bray reports that the drug was obtained by friends at no cost to him. The defendant relates that he experimented with cocaine in 1969 on a one time basis and denies any other use. Bray denies any problems with drugs or alcohol.
