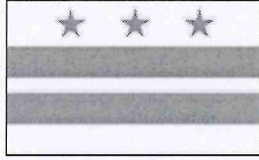



**ARTICLES OF INCORPORATION  
OF

We, the undersigned natural persons of the age of twenty-one years or more, acting as incorporator of corporation under the NON-PROFIT CORPORATION ACT (D.C. Code, 2001 Edition, Title 29, Chapter 3) adopt the following Articles of Incorporation:

- FIRST: The name of the Corporation shall be **MUSLIM PEACE FOUNDATION, (MPF) NH**
- SECOND: The period of the Corporation's duration shall be perpetual.
- THIRD: Muslim Peace Foundation (MPF) is a private, non-partisan, non-sectarian, non-profit institution dedicated to being an advocate for peace and reconciliation, mutual understanding and interfaith dialogue in America and throughout the world and dedicated to promoting any and all initiatives which will accomplish Muslim Peace Foundation's corporate mission.
- FOURTH: The Corporation shall have no members.
- FIFTH: The governance of the Corporation shall be vested in the Board of Directors of the Corporation. The authority of day-to-day business of the Corporation shall be delegated to the President whose office and responsibilities are defined in the Corporation's Bylaws.
- SIXTH: The manner in which the Corporation may be dissolved or liquidated shall be laid out in the Corporation's Bylaws.
